#### Background

In **FDI**, she advises on all aspects of foreign investment law in Indonesia, including the Negative List (a comprehensive list of sectors that are fully open, partly open or fully closed to FDI), the legal requirements for the establishment of an FDI company, documentation, the use of the OSS (Online Single Submission System – Indonesia's new online system for corporate licensing and approvals), accessing special facilities and incentives, regulatory and compliance issues, and all aspects related to doing business as a foreign investor in Indonesia. Her FDI mandates include advising Kencana Group on a joint venture agreement with PT Indotrast; Walmart in relation to
